Payment assistance is a type of subsidy that reduces the mortgage payment for a short time. The amount of assistance is determined by the adjusted family income. #### PET ETIQUETTE AND PET ORDINANCE REMINDERS

Several complaints, regarding dogs and cats, come into the City office and the Marshall County Sheriff's Department throughout the year. These are the most common complaints.

- If you are a pet owner, please remember these courtesies:
- 1. When walking your dog, bring along a rag and a bag to clean up any poo that your pet generates. Allowing a pet to 'go' freely on other people's property is a common complaint.
- 2. Dogs should be under the direct control of their owner at all times. If they do not obey commands, they should be leashed. Pets are not be allowed to run-at-large.
- 3. Another frequent complaint are dogs who bark in a continuous manner. This is against city statutes after 10:00 PM.
- 4. Please have your pets vaccinated annually.
