NEWFOLDEN IS AWARDED A \$600,000 MNDOT RAIL SERVICE IMPROVEMENT GRANT

The City of Newfolden was recently informed they will be awarded \$600,000.00 from the Minnesota Department of Transportation Rail Service Improvement Grant. Funding will be used to meet the cities financial obligation related to the Newfolden Flood Prevention Project.

The existing railroad crossing, over the Middle River and adjacent to Minnesota Highway 59, is scheduled to be replaced with a railroad bridge. This will eliminate the damn-like effect that is being created by a culvert system that is insufficient to convey peak flows during high water events. Construction is tentatively planned to be completed by the fall of 2022. The end-result will culminate in the removal of all of Newfolden's east-side properties from the 100 year flood-plain. This will protect property, preserve property values, and foster future development initiatives!

You may notice an additional fee of \$9.72 added onto the water portion of your June utility bill. This is the *Community Water Supply Connection Fee* and is mandated by the State of Minnesota. Minnesota Statute 144.3831, Subdivision 1 states that "the commissioner of health may assess a water fee of \$9.72 for every service connection to a public water supply operated by a home rule charter city, a statutory city, a city of the first class, or a town".

Subdivision 2 states "the public water supply referenced in subdivision 1 shall collect the fees assessed on its service connections and shall pay the Department of Health an amount equivalent to the fees based on the number of service connections".

The number of service connections the City of Newfolden has is certified every four years. This is a one time, annual fee, collected by June 30 of each year and paid quarterly to the Minnesota Department of Health.
